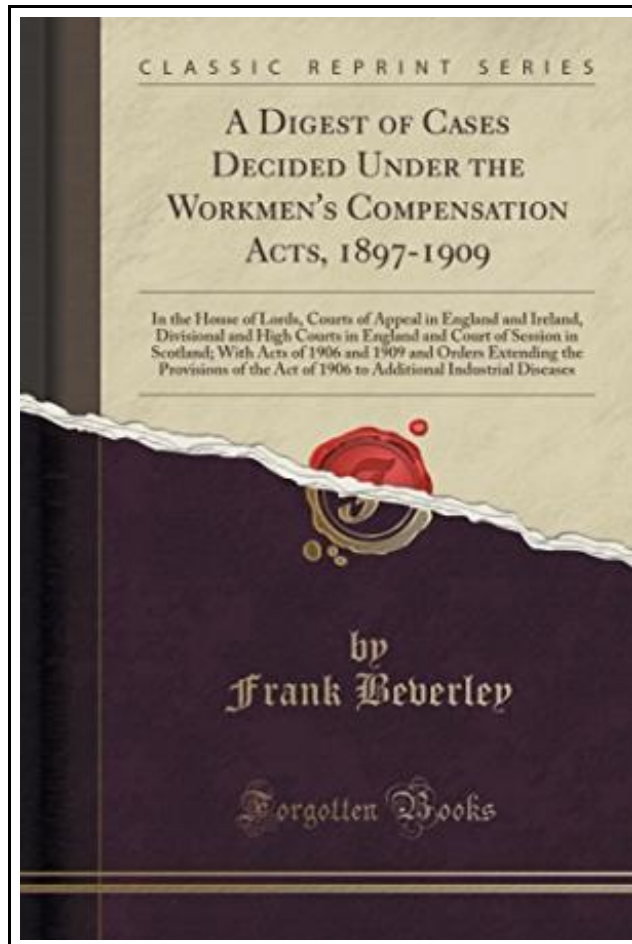

Only those cases which have not been overruled by subsequent decisions, and which have not been made ineffective in proceedings for compensation by the Workmen s Compensation Act, 1906, are included in the Digest portion. It is believed that all cases reported in the recognised reports down to and including January 6, 1912, are included in the present edition. Volume V. part I. of Butterworth s Compensation Cases did not come to hand until after the proofs had been revised. The cases which have been overruled, or which by reason of the Act of 1906 are not now applicable in workmen s compensation arbitrations, and which are shortly referred to on pp. 144-150, are now included in the Table of Cases. An Index of Subject Matter has been added which it is hoped may prove useful. The provisions of the Order in Council of 1909 modifying the Workmen s Compensation Act, 1906, in its application to workmen who are French Citizens, and sec. 11 of the National Insurance Act, 1911, have been included among the Statutes and Orders.
